Preamble:

Where as PRAGATI, is an Alumni registered society (under Registration of Societies Act, XXXI of 1860) of Jorhat Govt. Boys H.S. and M.P. School. The area of operation of the association is all rural and urban areas of Jorhat District, Assam.

The Kakojan College is an institution of higher education in the North East India situated in Kakojan, Jorhat, Assam. Affiliated to Dibrugarh University the college provides quality education offering Bachelor Degree and other Short term courses. The institution has already been re-accredited by National Assessment and Accredited Council (NAAC) in 2016 and awarded B+ grade on the basis of performance in the field of higher education.

Objectives:

The main objectives is to provide guidance and counselling programmes to guide students in career, personality, leadership and entrepreneurship development and to provide community services in the rural, flood affected and tea garden areas by creating awarness in areas of health, hygeine, education and agricultural sector.

Scope of MOU:

Kakojan College in collaboration with PRAGATI will take the initiative in the following areas.

- 1. To take initiative in organizing counselling programmes to guide students in education, career, personality, leadership and entrepreneurship development.
- 2. To organize awareness programmes in health and hygiene in various areas.
- 3. To organize environmental awareness and awareness on agricultural sector in specified areas.

Duration of the MOU:

This Memorandum shall enter into force on the date of its signing by both parties and shall take effect for a period of 3 (three) years. If this MOU is to be terminated without cause, a three months prior written notice should be sent by one party to another party. This MOU may be renewed by mutual written consent of both the parties.

Special Provision:

- 1. Both parties hereto shall do their utmost to ensure the smooth and efficient implementation of the programmes.
- 2. Both parties shall exert their best effort to be available for mutual consultation and shall give each other

necessary information whenever reasonably requested.

- Any amendment to this Memorandum of Understanding shall be made in writting and mutually agreed upon.
- 4. This Memorandum of Understanding shall be governed by and construed in accordance with the local laws.
