Department of Assamese, Kakojan College, JORHAT, ASSAM

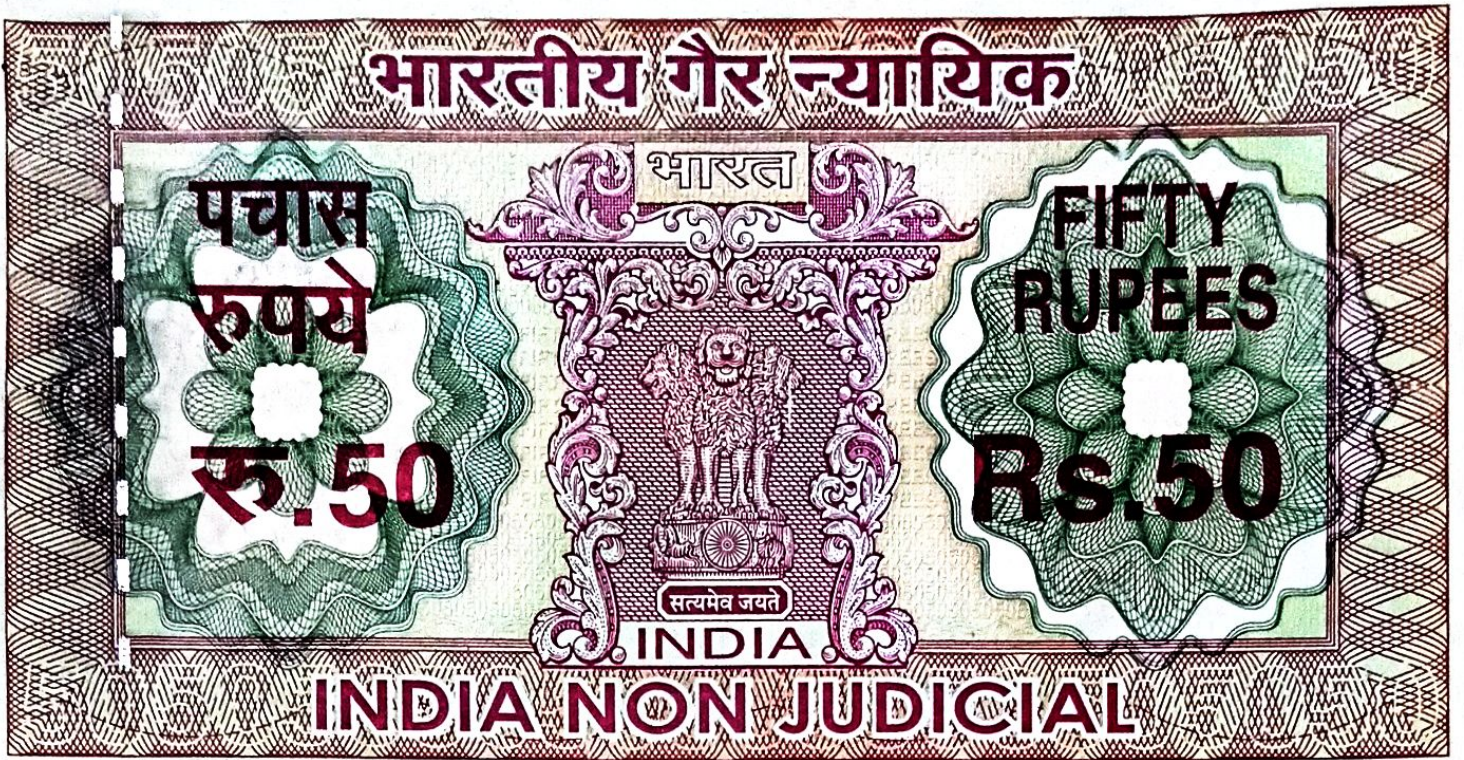
FOR DEVELOPMENT OF ACADEMIC PROGRAMMES AND COLLABORATION

**PREAMBLE:**

“DCB GIRLS’ COLLEGE”, Jorhat, Assam is a Girls’ college situated in Jorhat in Assam. It was established in 1955. “DCB GIRLS’ COLLEGE” is affiliated with Dibrugarh University, Assam. The College is accredited by NAAC.

“KAKOJAN COLLEGE”, Jorhat, Assam is a co-education institute situated at Kakojan, Jorhat, Assam. It was established in 1967. “KAKOJAN COLLEGE” is affiliated with Dibrugarh University, Assam. The College is accredited by NAAC.

**PURPOSE:**

The purpose of this MoU is to establish the terms and conditions under which both the parties agree to promote and develop the academic activities by mutual relationship.

**RESPONSIBILITIES:**

Under this MoU responsibilities will be fixed through mutual discussion between the two parties “DCB GIRLS’ COLLEGE” and “KAKOJAN COLLEGE” and mutually agree to provide assistance in terms of teaching, training and to organise academic programmes like Interactive Lecture, Workshop, Seminar, Webinar, Conference, Symposium etc.

## **GENERAL PROVISIONS:**

- i) Alteration or Change:** Either party may request to alter or change this MoU. The alteration, change, modification, revision or amendment to this MoU which are mutually agreed upon by the parties to this MoU shall be incorporated by a written instrument, and the alteration or change or amendment shall be effective after executing or signing by both the parties of this MoU.
- ii) Terms of Validity:** Initially this agreement shall be valid for four years from the date of signing and execution of this MoU and can be renewed subsequently by mutual consent of both the parties.
- iii) Terms Extension and Renewal:** The terms of extension and renewal to this MoU will be fixed by the mutual agreement in written only signed by each Parties authorized signatory.
- iv) Implementation:** Each college shall designate a coordinator to develop and coordinate specific activities or programmes. The terms of such mutual assistance and the necessary budget for each specific programme and activity that is to be implemented under the terms and conditions of this MoU shall be discussed and agreed, prior to the initiation.
- v) Assignment:** The rights or and liabilities arising to any part to this MoU shall be assigned or fixed only with the written consent of the other party and subject to such terms and conditions as may be agreed upon between the involved parties otherwise it will be regarded as contrary to the MoU.
- vi) Settlement:** Any dispute or unwanted means arising with regard to any aspect of this MoU shall be settled through mutual consultation and agreement by the parties to the Agreement
- vii) Termination:** Both the parties have right to terminate this agreement in case any party fails to abide by the conditions of the MoU, through a written notice of at least three months.
- ix) Communication:** The parties to this MoU must give all information/notices under this MoU in writing only, and all communications must be sent to the official e-mail addresses or to such other address designated by the both college.

## **5. Agreement**

- i) Both parties are agreed to organise Seminar, Symposium, Conference together**
- ii) Both parties are agreed to exchange students and faculties for academic purposes,**

- iii) Both parties are agreed to work together for promotion of Assamese language, literature and culture.
- iv) Both parties are agreed to work together to enhance the interest of students in the subject.
- v) Both parties are agreed to enhance creative writing skills in students who aspire to be writers.
