MEMORANDUM OF UNDERSTANDING (MOU)

BETWEEN DEPARTMENT OF POLITICAL SCIENCE NANDA NATH SAIKIA COLLEGE, TITABAR, ASSAM

> DEPARTMENT OF POLITICAL SCIENCE KAKOJAN COLLEGE, JORHAT, ASSAM

Established in 1959, Nanda Nath Saikia College is a leading provincialized college affiliated to Dibrugarh University, Assam. The College is located in Titabar town, about 21 km from the district headquarter of Jorhat and recognized as one of the premier institutions of the region in the field of Higher Education. The Department of Political Science is the premier department and was established in 22nd July, 1959. The Department works for academic excellence and community upliftment from its inception.

Kakojan College was established on 24th July, 1967 with the contribution of the public educationalist, social Workers etc. Even the baggers and widows offered pie for it. The college is situated in a rural area at the center of 12-15Km radius surrounded by the M.O.B.C, O.B.C, General Classes, Tea Garden and ex-tea garden labours, tribal and economically backward and flood affected families. At present, it has been imparting higher education in Arts in

undergraduate level. The science stream has been stated in 1994.

The college has come under deficit system of grant in aid with effect from 01/09/1981 and registered under U.G.C 2(f) Act on 12th Dec, 1998. The college is provincialized by the govt. of Assam in 1st Dec, 2005. In the last two decade the college has shown distinguish result in the faulty of arts including 5th Position in the year 2001 and 1st Position in the year 2009 in H.S. Level and first class in various subjects in degree level.

This memorandum of understanding is made executed on 05/08/2021, between the Department of Political Science, Nanda Nath Saikia College, Titabar, Assam and Department of Political Science, Kakojan College, Jorhat.

Purpose and objective of the MoU

The Department of Political Science, Nanda Nath Saikia College and Department of Political Science Kakojan College, Jorhat, Assam both undertake to promote and develop academic cooperation as follows:

- · Exchange of academic and administrative staff and students;
- · Extension of students' learning opportunities;
- The Parties intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education and Placement for students:
- · Exchange of cultural activities;
- · Cooperation in research and the presentation of its results;
- · Exchange of academic materials, publications and other scientific information; and
- · Other educational and academic exchanges.

TERM AND TERMINATION:

- 1. This Agreement shall commence from the Effective Date and shall continue to be in force for a period of five (5) years thereafter ("Term"), unless renewed further or earlier terminated. The Agreement may be renewed or extended by mutual agreement (in writing) between the Parties at any time during the Term.
- 2. Notwithstanding anything herein contained, either Party may forthwith terminate this Agreement immediately under any one or more of the following conditions:
 - a. In the event of a remediable breach of this Agreement by the other Party that remains uncured for a period of seven (7) days after written notice of breach to the defaulting Party by the aggrieved Party;
 - b. It can be extended if the review committee recommends it
 - c. This MOU will be automatically invalid after five years unless

Amendment and Waiver:

Any provision of the Agreement may be amended or waived if, and only if such amendment or waiver is in writing and signed, in the case of an amendment, by each Party, or in the case of a waiver, by the Party against whom the waiver is to be effective.

Entire Agreement:

The Agreement constitutes the entire agreement between the Parties with respect to the subject matter hereof and supersedes all prior written agreements, understandings and negotiations, both written and oral, between the Parties with respect to the subject matter of the Agreement.

No Third-Party Beneficiaries:

Neither the Agreement nor any provision hereof is intended to confer upon any Person other than the Parties to the Agreement any rights or remedies hereunder.

Severability:

The invalidity or unenforceability of any provisions of the Agreement in any jurisdiction shall not affect the validity, legality or enforce-ability of the remainder of the Agreement in such jurisdiction or the validity, legality or enforceability of the Agreement, including any such provision, in any other jurisdiction, it being intended that all rights obligations of the Parties hereunder shall be enforceable to the fullest extent permitted by law.

Legal Fees:

Each Party is to pay its own legal costs and disbursements incidental to the preparation, completion and signing of the Agreement.

Stamp Duty:

Each Party shall equally pay the stamp duty or other levy or charge (including any penalties or fines) which payable on this document or in respect of any transaction is referred to in this document and any documents which are executed in accordance with the provisions of this document to effect those transactions.

Assignment:

Neither Party may assign, in whole or in part, the benefits or obligations of the Agreement to any person other than an affiliate without the prior written consent of the other Party. 9.10. Counterparts: The Agreement may be executed in counterparts, each of which when executed shall constitute an original, but all of which when taken together shall constitute one and the same Agreement.

Dispute Resolution:

Any dispute arising between the Parties in relation to this Agreement and/or any Project Statement shall be resolved by a sole arbitrator through arbitration under the terms of the Arbitration and Conciliation Act, 1996 at Jorhat, India
