**MEMORANDUM OF UNDERSTANDING (MOU)
BETWEEN
ANNAPURNA SEED LENDING LIBRARY, MELENG, JORHAT, ASSAM
(The First Seed Library In North East India)
AND
KAKOJAN COLLEGE, JORHAT, ASSAM**

This Memorandum of Understanding (hereinafter called as MOU) is executed between Annapurna Seed Lending Library, Meleng, Jorhat, Assam, the first Seed Library in North East India and first Sister Library from Asia in Richmond Grows Seed Lending Library and Kakojan College, Jorhat, Assam, an Institution of Higher Education, affiliated to Dibrugarh University, Assam.

The aim of this document is to record an understanding between Annapurna Seed Lending Library and Kakojan College, Jorhat, Assam by which both the parties may cooperate in establishing closer links in the following domains –

- 1) To take initiative in creating awareness amongst students and neighbouring people on preservation of indigenous seeds.

- 2) To work together for the mission 'Save our Soil and Seed for our Future Food Security'.
- 3) To organize programmes on protection of the seeds and agro diversity in the region.
- 4) To work together for the promotion of Natural Farming Practice among the farmers and young generation for protecting Air, Water, Soil and Biodiversity of this region.
- 5) To organize training programmes at community level.

It is proposed that the closer link be initially established in the following areas.

- 1) Cooperation in creating awareness on seed preservation amongst students and rural people.
- 2) Promoting and encouraging the concept of save our soil and seed for future food security.
- 3) Organizing programmes for promotion of indigenous seed preservation.

Statement of Understanding

The documents is state of understanding and is not intended to create binding on Legal obligation on either party.

This agreement shall commence from the effective date and shall continue to be in force for a period of **Four (04)** years. The agreement may be renewed or extended by mutual agreement between the parties at any time during the term.
